Regional Commonality

- Droughts (leading to dependence on alternative water resources)
- Floods (increasing the volume of surface water runoff)
- High Population Density (increased global water demand)
- Climate Change (causing uncertainty and the need to prepare for a climate resilient framework)

Such projects also open future possible project collaborations that can act as a continuation to previous projects. Therefore, also incentivize future innovation.






LIFE IP 16 00008/MT

- Includes a variety of best practices which have been identified during the implementation of Malta's 2nd RBMP Programme of Measures.
- Will be exchanged during the final stages of the project, in order to enhance its outcomes and improve it.
- Aims to provide an inter-evolving methodology that can be easily adaptable in different case studies and local contexts.

- In the context of a physically isolated country like Malta, the meaning of transboundary goes something that goes beyond water.
- Through transboundary cooperation, the country is enabled to exchange experiences and challenges between
 regions that share the same challenges as Malta.
- Such cooperation also enables a higher-paced level of innovative approaches and technologies to be adopted and become mainstream to address current and future challenges.
