### **Technical and cultural study visit**

#### **Option 1: Local Life in Finnish countryside -Tour with a lake cruise**

Finnish Lakeland and summerly countryside scenery at its best!

Come aboard and enjoy a 2 Hour lake cruise from Lahti to Vääksy Canal. After arriving in summer village Vääksy, a tasty Lunch with seasonal local fish from Lake Päijänne will be served in a local restaurant. After lunch guided visits in Vääksy Mill & Shop and a family owned microbrewery Kanava Brewery – with some tastings too!

Vääksy canal combines two lakes; Lake Vesijärvi and the second largest lake in Finland - Lake Päijänne.

The canal is one of the busiest water routes in southern Finland. This area is also one of the most famous summer cottage areas in Finland due to the beautiful lake nature. On this guided tour you'll learn all about the local life and nature surrounding. Return to Lahti by bus, 40 Min.

Duration: 4,5 hours. Starts: 10h00 Lahti Passenger Harbor. Ends: 14:30 in Lahti city center.

Group size: min 20 max 45 persons

Please note: Cruise departs from the harbor at 10h00, so be there latest at 09h45.

#### **Option 2: Guided Canoeing excursion**

Canoeing Excursion starts from Lahti Passenger Harbor where local instructors of Lahden Vesisamoilijat (local canoeing club) give participants a short instruction on canoeing in a safe way. All equipment incl. life vests are included. Group paddles together to Myllysaari island where a delicious soup lunch will be served in a local Sailing Club's home harbor restaurant. After lunch, return by canoeing to Lahti passenger harbor. Previous experience is not required, this excursion is perfect also for beginners.

Duration: 3,5 hours. Starts: 10h00 from Lahti Passenger Harbor. Ends: 13h30 at Lahti Passenger Harbor. Group size: min 5 max 10 persons

Please note: Take some dry changing clothes with you - you might get wet during paddling.

Excursion is depending on Weather conditions (wind), confirmation of the tour will be given day earlier.
