



# Drafting of a Report for the World Bank on "Resource Allocation and Water Rights: The Case of Spain"

- This report resulted from an invitation from the **World Bank**, within their actions for the compliance with their compromise with the Turkish Government, in their approach to some **water management policies** close to those in the European Union, particularly the Water Framework Directive.
- The report has the objective of being a reference for the Turkish Government in the development of their **new water policies**, in order to achieve an **integrated and sustainable management**.
- •The report was presented during a workshop celebrated in Ankara (Turkey) in September 2013.



#### **OECD Water Governance Initiative**

• The OECD Water Governance Initiative is an international multistakeholder network of members from the public, private and non-for-profit sectors gathering twice a year to share good practices in support of better governance in the water sector.

#### **OBJECTIVES**

**Advise governments** in taking the needed steps for effective water governance reforms through policy dialogue across decision-makers at different levels.

**Provide a technical platform** to discuss analytical work on water governance through peer-to-peer exchanges and knowledge sharing.

**Provide a consultation mechanism** to raise the profile of governance issues in the Global Water Agenda (World Water Forum, Post-2015 Agenda).

 MENBO has been represented in all the WGI meetings (since 2013) with an active role in the elaboration of the principles and technical contributions.



- •To be implemented depending on each country's range of challenges, conditions, specificities and different levels of capacities.
- •Promotes financing opportunities.

# PEER REVIEW: Establishment of a Peer Review mechanism for the implementation of the Water Framework Directive (2015-2016)

#### Objective:

To set up a voluntary and targeted system of cooperation between competent authorities (Peers) to allow mutual learning about the implementation of the WFD and river basin management planning.

MENBO is part of the coordinating consortium and assists in the match-making process between experts and basins, organises missions to be developed in the different River Basin Authorities, and reports to the rest of the coordinators on the progress of these missions.

# End-to-end Demonstrator for improved decision making in the water sector in Europe (EDgE) Dec.2015 – Dec.2017

#### Objective:

To provide climate-derived information to the water sector community for improved decision making regarding mitigation and adaptation strategies in Europe at timescales from seasonal to multi-decadal. It aims to develop a Sectoral Information Service (SIS) to target key users with different needs.

MENBO is part of the consortium and member of Work Package 1, leading the activity regarding case studies from River Basin Authorities in the Mediterranean.

Possibility of celebrating an EDgE Workshop during the next EURO-INBO Lourdes (France) 2016.
